

SPECIAL CONDITIONS OF PARTICIPATION

for HAM RADIO 2021



DEFINITIONS

MFN: Messe Friedrichshafen GmbH shall hereafter be referred to as „MFN“.

OSC: Exhibitors receive an access code for the Messe Friedrichshafen Online Service Center (hereafter referred to as „OSC“) upon stand allocation. Media features as well as technical and organizational orders must be executed via the OSC.

1 GENERAL EVENT INFORMATION

1.1 Opening times:

The HAM RADIO will take place from June 25th to June 27th, 2021 at the MFN exhibition grounds in Friedrichshafen. The exhibition is open Friday through Saturday from 9:00 a.m. to 6:00 p.m. and Sunday from 9:00 a.m. to 3:00 p.m. The right to alter the opening times due to serious reasons is reserved. Changes will be announced in good time.

Access for exhibitors: 1 hour before start of the exhibition and 1 hour after the end of the exhibition.

1.2 Set-up and dismantling times:

1.2.1 Set-up:

Wednesday, June 23rd, 2021 7:00 a.m. – 8:00 p.m.

Thursday, June 24th, 2021 7:00 a.m. – 10:00 p.m.

Advanced stand set-up has to be approved by the project management and is subject to charge. It can be ordered via OSC.

1.2.2 Dismantling:

Sunday, June 27th, 2021 3:00 p.m. – 10:00 p.m.

Monday, June 28th, 2021 7:00 a.m. – 6:00 p.m.

Tuesday, June 29th, 2021 7:00 a.m. – 12:00 p.m.

Early dismantling is not permitted. Please refer to the General Conditions of Participation. In case of non-compliance, MFN reserves the right to impose sanctions.

1.3 Additional deadlines:

Registration requested by February 1st, 2021

Start of floor planning: March 1st, 2021

1.4 After admission, all services may be ordered via the OSC. The access code for service orders and media entries will be sent with the acceptance documents per e-mail.

1.5 Stand fittings:

Within the participation fee following stand fittings are included: partition walls, 1 table (1.40 x 0.80 m), 4 chairs and main power. If you should require additional furniture (tables, chairs, beer tables or counters), you have to order it separate (with costs). Tables and chairs will be delivered to your stand during set-up.

1.6 Associations and organisations are not entitled to exhibit and/or to sell goods. Exceptions from this rule are only made by the trade fair management. Goods not authorized by the trade fair management will be removed at the expense of the association/organisation.

1.7 Wifi: MFN has its own Wifi, which exhibitors and visitors can log onto and is free of charge. Exhibitor's own Wifi must be registered and comply with specific conditions. Registration and prerequisites can be accessed via the OSC.

1.8 GEMA: exhibitors have to register the use of copyright music, videos or movies with the German authority GEMA. Registration forms are available at: www.messe-friedrichshafen.com/exhibiting-guidelines

2 REGISTRATION AND ADMISSION

Registration (participation and stand order placement) for the HAM RADIO 2021 is made by using the online form on HAM RADIO website or PDF registration form, which must be completely filled out and signed as legally binding. This registration is an offer of a contract, which requires acceptance by MFN. Submission of the registration form shall not constitute a claim for acceptance.

The written participation of MFN with disclosure of the allocated stand (stand confirmation) and the accompanying participation invoice shall be considered as admission to the HAM RADIO. If the content of the stand confirmation differs from the content of the exhibitor's registration, the contract shall take effect in accordance with the stand confirmation, **unless the exhibitor objects in writing within two weeks.**

3 PARTICIPATION FEE / EXHIBITOR PASSES AND PARKING PERMITS

- 3.1.3** Exhibitor passes and parking permits
 The participation fee includes following free amount of exhibitor passes and parking permits:
 Up to 15 sqm: 4 exhibitor passes and 2 parking permits
 From 16 sqm on: 6 exhibitor passes and 3 parking permits

3.2 The co-exhibitor fee is € 80.00 / co-exhibiting association / organisation. Definition of co-exhibitor: see General Conditions of Participation. Co-exhibitors will receive 4 exhibitor passes and 2 parking passes for free.

All quoted prices are net prices and pertain to the entire duration of the exhibition. If the statutory value added tax applies, it will be invoiced in addition. Please note concerning this the explanations of the reverse charge procedure and the VAT identification number in the General Conditions of Participation.

4 TERMS OF PAYMENT

All invoices are payable by May 1st, 2021. Invoices issued after May 1st, 2021 are to be paid in full immediately after receipt of invoice without any deductions. The same applies to all other MFN invoices. Please note the payment due dates and information about the bank accounts on the MFN invoices.

5 STAND CANCELLATION / CANCELLATION FEE

In case of cancellation after registration Messe Friedrichshafen has the right to invoice up to 50% of invoiced total. In case of cancellation 4 weeks prior to the opening and later penalty will be 100% of invoiced total.

6 ADDITIONAL SERVICES

- 6.1** In addition to the participation fee, the acceptance of the following services is obligatory:
- The AUMA fee of € 0.60/sqm to be paid by the exhibitor will be invoiced by MFN for the AUMA and passed on.
 - All exhibitors will be included in a printed index of exhibitors as well on the website of the HAM RADIO. An entry will be made in the alphabetical directory with information about the exhibitor's offerings. The mandatory entry in the exhibitors directory is included. The entry can be edited in advance by the exhibitor in the OSC. The deadline for the close of editing will be announced with the notification of the OSC access code.
 - Flat fee for general waste disposal: €1.00/sqm max. € 75.00
- 6.2** Additional services can be ordered via the OSC. All prices are net prices.

7 LEGAL NOTICES

- 7.1** Violation of the exhibition terms and conditions gives MFN the right to close stands immediately and to clear them off without requiring court action. This applies in particular to cases of advertising in contravention and in case of advertising for political or ideological purposes.
- 7.2** The German version of the contract is binding.
