1 GENERAL EVENT INFORMATION

1.1 Opening times:

The virtual HAM RADIO will take place from June 25th to June 27th, 2021 online.

1.2 Stand creating

Stands can be created online. Depending on the chosen package, stands will be created by the exhibitor or MFN. If the stand is created by the exhibitory himself, he will receive instructions on how to create it.

2 REGISTRATION AND ADMISSION

Registration (participation and stand order placement) for the virtual HAM RADIO 2021 is made by using the PDF registration form, which must be completely filled out and signed as legally binding. This registration is an offer of a contract, which requires acceptance by MFN. Submission of the registration form shall not constitute a claim for acceptance. The contract is concluded upon receipt of the participation invoice.
